2021 Annual Meeting:

The date for the 2021 Annual Membership Meeting has been set for Monday, January 4, 2021 at 7:00 PM at the Strongsville Library. Please mark your calendars and plan to attend the meeting. Three new Board members will be elected at that meeting. **PLEASE NOTE THAT LIBRARY MEETING ROOM RESERVATIONS ARE SUBJECT TO CANCELLATION DUE TO THE COVID STATUS AT THE TIME OF THE MEETING. A BROADCAST EMAIL WILL BE SENT TO RESIDENTS IF A CANCELLATION TAKES PLACE.**

Nominations for election to the Board are needed. Please consider placing yourself or one of your neighbors who agrees to run in nomination. The term is for two years and responsibilities consist primarily of attending four meetings per year, usually lasting less than two hours. The Association maintains common grounds including the playground, detention basins and entrance ways. Nomination information is attached to this newsletter. Please review it and send in a nomination so all Board positions can be filled.

Annual Meeting Proxies – Important COVID Information!

The Association's Documents require that an Annual Meeting must be held and that at least 50% of the membership appear at the Annual Meeting either in person or by proxy for the meeting to be valid. **If the 50% quorum is not met, the meeting must be adjourned and rescheduled; Association business cannot be conducted unless a quorum is achieved.** A proxy form is attached. Please sign and send in this form in the enclosed return envelope whether you plan to attend the meeting or not. If you do attend the meeting in person, you may waive the proxy at the meeting and do all voting in person.

Given the uncertainty of the COVID progress, the requirement for a quorum, and the desire of many residents not to attend such meetings in person, it is very important that you send in your proxy this year; if your status at the time does allow your attending, you may waive the proxy and do all voting in person.

Landscaping:

All landscape projects planned for 2020 have been completed. Please note that painting of the fences, playground equipment and gazebo was also completed in 2020.

Association Trustee Nomination

Three association trustees' terms expire in 2020. There is an immediate need for three residents to volunteer their time for the next two-year term. If you are interested in getting involved in the actions and directions of your community, please submit your name for inclusion on the ballot
