2023 Annual Meeting:

The date for the 2023 Annual Membership Meeting has been set for Wednesday, January 4, 2023, at 7:00 PM at the Strongsville Library. Please mark your calendars and plan to attend the meeting. Three new Board members will be elected at that meeting.

Nominations for election to the Board are needed. Please consider placing yourself or one of your neighbors who agrees to run in nomination. The term is for two years, and responsibilities consist primarily of attending four meetings per year, usually lasting less than two hours. The Association maintains common grounds including the playground, detention basins and entrance ways. Nomination information is attached to this newsletter. Please review it and send in a nomination so all Board positions can be filled.

Annual Meeting Proxies:

The Association's Documents require that an Annual Meeting must be held and that at least 50% of the membership appear at the Annual Meeting either in person or by proxy for the meeting to be valid. If the 50% quorum is not met, the meeting must be adjourned and rescheduled; Association business cannot be conducted unless a quorum is achieved. A proxy form is attached. Please sign and send in this form in the enclosed return envelope whether you plan to attend the meeting or not. If you do attend the meeting in person, you may waive the proxy at the meeting and do all voting in person.

Landscaping:

One major landscape project was planned for 2022, which was upgrading the North Detention Basin. This was done to ease meeting city and county standards and to preserve residents' monthly NEORSD stormwater credits. The project was completed in August. Before and after pictures have been posted on the Association's web site in the Newsletter section. Please check them out.

The Association's three year landscaping contract expires this December. A new contract is being negotiated. The ongoing inflation issue has yielded a significant increase in contract costs, and this increase will be reflected in the 2023 budget and dues levels. Final information will be distributed In November.

Neighborhood Watch:

Incidents of suspicious activity around autos parked in residents' driveways have been reported. Please be sure to lock your car and remove any valuables if you must park in your driveway overnight.

Association Trustee Nomination
