2024 Annual Meeting:

The date for the 2024 Annual Membership Meeting has been set for Wednesday, January 3, 2024, at 7:00 PM at the Strongsville Library. Please mark your calendars and plan to attend the meeting. Two new Board members will be elected at that meeting.

Nominations for election to the Board are needed. Please consider placing yourself or one of your neighbors who agrees to run in nomination. The term is for two years, and responsibilities consist primarily of attending four meetings per year, usually lasting less than two hours. The Association maintains common grounds including the playground, detention basins and entrance ways. Nomination information is attached to this newsletter. Please review it and send in a nomination so all Board positions can be filled.

Annual Meeting Proxies:

The Association's Documents require that an Annual Meeting must be held and that at least 50% of the membership appear at the Annual Meeting either in person or by proxy for the meeting to be valid. If the 50% quorum is not met, the meeting must be adjourned and rescheduled; Association business cannot be conducted unless a quorum is achieved. A proxy form is attached. Please sign and send in this form in the enclosed return envelope whether you plan to attend the meeting or not. If you do attend the meeting in person, you may waive the proxy at the meeting and do all voting in person.

Association Trustee Nomination

Two association trustees' terms expire in 2023. There is an immediate need for two residents to volunteer their time for the next two-year term. If you are interested in getting involved in the actions and directions of your community, please submit your name for inclusion on the ballot

Nominations should be submitted before November 15, 2023, so ballots can be distributed. If fewer than two nominations are received by November 15, 2023, nominations will be held open until the Annual Meeting.
